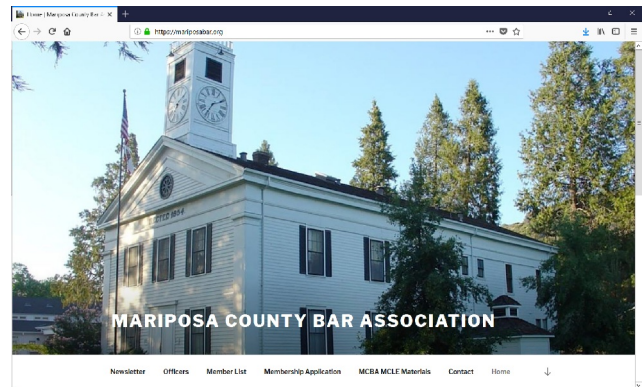
Our 2018 membership dues are \$35.00 for the remainder of the year, and we have attached an application, so be sure to send in your application and dues to get your listing on the new website!

The MCBA Is on the Way to Becoming an MCLE Multiple Provider

Every three years attorneys must obtain 25 Minimum Continuing Legal Education (MCLE) credits, including four hours in legal ethics, one hour in competence, and one hour in recognition and elimination of bias.

The MCBA has commenced the process of becoming an MCLE provider! Once we attain this status, we will be able to provide MCLE credits at our regular monthly luncheon meetings.



There are two types of MCLE providers: "single activity provider" and "multiple activity provider." A single activity provider must apply to the State Bar for approval of the MCLE credit six weeks in advance, including submitting the course material and the biography of the speaker.

To qualify as a multiple activity provider, the provider must have four separate single activity MCLE sessions approved by the State Bar. After that, the provider may apply for status as a multiple activity provider, with renewal every 3 years.

At this time, the MCBA is in the process of applying for the following four presentations to be approved by the State Bar:

1. Judge Michael Fagalde, for .5 hours MCLE credit in ethics
2. David Mann of The Other Bar for 1 hour MCLE credit in competence/substance abuse
3. Digital Forensics on Ethics and Digitally Stored Information, for 1 hour MCLE credit in ethics
4. Kimberly Flores, regarding probate or employment law, for 1 hour MCLE credit
