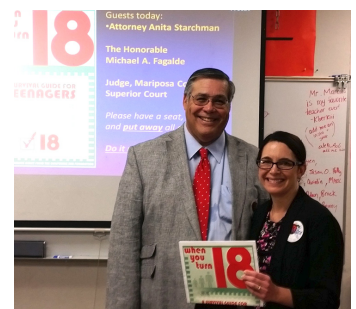
An election for the 2019 Officers will take place in November 2018 with the new panel of officers being installed in January 2019.

Judge Fagalde to Speak at July MCBA Meeting

The MCBA is honored to have Judge Michael A. Fagalde speak at their next luncheon meeting on Monday, July 9, 2018 at 12:00 p.m. at the Miner's Roadhouse 140. Judge Fagalde will provide a presentation regarding Updates and Changes in Behavioral Health, as it relates to Mariposa County.

Judge Fagalde was elected to the Mariposa County Superior Court in 2014. Prior to becoming a Judge, he received his undergraduate degree from San Jose State University, went on to earn his Juris Doctor from Santa Clara University in 1983, and was voted "Best Attorney" by the local newspaper. He has been very active in the community, serving on the Mariposa County Bar Association, the Mariposa Rotary Club, Board of Directors of the John C. Fremont Hospital Foundation, and Board of Directors of the Mariposa School Foundation.

Judge Fagalde has also assisted our local attorneys in presenting the "When You Become 18" program, which has been arranged for over 10 years by attorney Anita Starchman Bryant, our MCBA Secretary. The MCBA Is on the Way to Becoming an MCLE Multiple Provider

Every three years attorneys must obtain 25 Minimum Continuing Legal Education (MCLE) credits, including four hours in legal ethics, one hour in competence, and one hour in recognition and elimination of bias.

The MCBA has commenced the process of becoming an MCLE provider! Once we attain this status, we will be able to provide MCLE credits at our regular monthly luncheon meetings under our own provider status.

There are two types of MCLE providers: “single activity provider” and “multiple activity provider.” A single activity provider must apply to the State Bar for approval of the MCLE credit six weeks in advance, including submitting the course material and the biography of the speaker.

To qualify as a multiple activity provider, the provider must have four separate single activity MCLE sessions approved by the State Bar. After that, the provider may apply for status as a multiple activity provider, with renewal every 3 years.

Until we attain our provider status, all presentations qualifying for MCLE credit will be under the provider status of the presenter.
