## Attend Our August 13, 2018 Luncheon for 1 Hour MCLE Credit in Substance Abuse!

We are excited to have David Mann of The Other Bar as our guest speaker for our luncheon meeting on August 13, 2018 at 12:00 p.m. at the Miner's Roadhouse 140, banquet room. Mr. Mann will provide a presentation entitled Competence: Substance Abuse in the Legal Profession.

In this presentation, Mr. Mann provides a review of the

brain chemistry of addiction and alcoholism, as well as a discussion of the behavioral and health consequences of the disease. Insights are offered into the personality traits of attorneys and the qualities of the legal profession that combine to make lawyers significantly more susceptible to addiction, and more difficult to treat, than the general population.



The presentation identifies and discusses the detection of substance abuse issues that impair an attorney's ability to perform legal services with competence. It includes a case study of an addict attorney, as well as a self-diagnosis exercise for attorneys to utilize if they are concerned that they may have a problem which needs to be addressed.

### August 13, 2018 Luncheon, *continued*

Concluding remarks are directed towards both systemic and individual solutions to the problem, with references to specific strategies and resources available. Mr. Mann approaches this very serious topic in a manner that incorporates humor and irony and invites attorneys to engage in a bit of sometimes much-needed self reflection.

David Mann is a graduate of Ohio State University and Stanford Law School. He served as a Deputy Public Defender in San Francisco before becoming a solo criminal defense practitioner. After 12 years of practice, substance abuse-related issues caused him to resign from the bar with disciplinary charges pending. Following a relentless battle with addiction

which included numerous hospitalizations and periods of living on the streets, he succeeded in getting clean and sober in 1998. Since then he has worked, among other things, as a cab driver, a private investigator, a paralegal, and a drug and alcohol rehabilitation counselor.



Mr. Mann presently serves as the Northern California Consultant to The Other Bar, a statewide organization of recovering attorneys, judges, and law students. In this capacity, he spends his time providing outreach and education to the legal community, and assisting attorneys as they struggle with substance abuse and related challenges that threaten their ability and/or eligibility to practice law.

#### Sidebar

On May 23, 2018, the Supreme Court issued California Rule of Court, Rule 9.9.5, requiring the re-fingerprinting of most active attorneys licensed in California, effective June 1, 2018. The deadline to submit proof that you have been fingerprinted is April 30, 2019.

Failure to follow these instructions may be considered non-compliance with the California State Bar fingerprinting rule requirements and may subject attorneys to penalties.

To obtain the form for your livescan, you must log into your State Bar account and download the form. Each attorney's form will contain a unique identification number assigned by the DOJ. Once you have downloaded your form, you must have your livescan performed by an authorized vendor. The livescan vendor will collect the \$49 fee for the FBI and DOJ background checks. Each vendor charges an additional "rolling" fee for conducting the scan, which ranges from \$5 to \$75. The most reasonably priced vendor in a several county area is our own Mariposa County Sheriff's Department, which charges only \$5.00 for the rolling fee.
