# Join Us for MCLE Credit at March 11, 2019 Luncheon

Our March 11, 2019 luncheon speaker will be Casey Aitchison of the Merced and Mariposa law firm Aitchison & Emery. Ms. Aitchison's presentation, Standards and Best Practices in Family Law, has been approved by the California State Bar for 1 hour of MCLE credit.

Ms. Aitchison has been a family law attorney for 30 years. In addition to family law, she practices law in the related areas of guardianships, adoption, and juvenile dependency, and is frequently appointed by the Superior Court to represent children as minor's counsel. Ms. Aitchison regularly serves as Judge Pro Tempore of the Merced County Superior Court, Family Law Division, and has served in that capacity for the Mariposa County Superior Court as well.

Ms. Aitchison currently serves as President of the Mariposa County Bar Association and President of the Family Law Section of the Merced County Bar Association. She is a member of the National Association of Counsel for Children, the Association of Family and Conciliation Courts, and the State Bar of California. She is appointed to serve on the Board of Trustees of the Merced County Law Library, and served as President of the Merced County Bar Association in 2018.

Prior to law school, Ms. Aitchison served as a Congressional Page before going on to receive her undergraduate degree in Business Management. In 1989, she earned a Juris Doctor from San Joaquin College of Law in Fresno, California, where she served as President of the Student Bar. She passed the California Bar exam in 1989 and worked for a law firm in Merced prior to founding her law practice in 1994. In 2018, attorney Skye Emery became a partner in the law firm and they established the family law firm Aitchison & Emery.

After raising her children in Merced and seeing them off to college, Ms. Aitchison now resides in Catheys Valley, where she and her husband own and operate California's largest alpaca ranch.

## Legal Aid for Mariposa Residents

A new legal aid program for Mariposa County senior citizens rolled out on February 1 at the Mariposa County Senior Center. It is sponsored by the Mother Lode Office of Catholic Charities under a grant from the Area 12 Agency on Aging, and Central California Legal Services (CCLS). There is no



cost to Mariposa residents for this service.

The program is available only to senior citizens age 60 and over. It offers services in limited areas, including estate planning, landlord/tenant issues, fraud upon seniors, contracts, and other simple concerns. Other more complex services that could be available include immigration and social security issues. One area specifically excluded from the service is any kind of family law issue.

The legal services are provided by attorneys from CCLS who travel to Mariposa the first Friday of each month. Mariposa residents must make an appointment with Catholic Charities, although limited walk-in service is available.

The Mariposa County Bar Association (MCBA) is monitoring the program and exploring the possibility of partnering and/or assisting in that effort.

One area where Mariposa County Bar Association members can be of assistance is with referrals where the legal aid program cannot assist clients. Typically, this type of program would refer those cases to local attorneys for fee-based assistance. MCBA has made it's list of members and practice areas available to CCLS for these referrals. Any such referral would be treated like any other client contact with fees and services negotiated between the parties.

Another area where MCBA members can be of assistance is with family law matters. No such services are offered as part of this program. Service enhancements could include legal advice, or even occasional clinics on basic family law procedures.

A third area where MCBA members can assist is with expanding this service to residents under the age of 60, offering services similar to those now offered to seniors.

# **Congratulations to Mariposa's Newest** Minor's Counsel!

The Mariposa County Bar Association was represented by a strong contingency at the Minor's Counsel Training Symposium in San Luis Obispo during February 2019.

The MCBA would like to congratulate attorneys Ashley Albertoni, Alex Albertoni, and Stephanie Perez for completing the requisite training for qualification to accept appointments by the Mariposa County Superior Court to represent minor children in family law custody proceedings. All three attorneys bring a rich array of life experience and dedication to their newly acquired qualifications as minor's counsel. Featured articles regarding these three attorneys who comprise Mariposa's newest minor's counsel, are set forth below.

Other Mariposa County Bar Association attorneys who attended the training to renew their longstanding qualifications to accept appointments as minor's counsel were Deborah Bennett, Cindy Morse, Skye Emery, and Casey Aitchison. The faculty at the symposium was an impressive line-up, including Judge Thomas Trent Lewis, the Supervising Judge for the Los Angeles County Superior Court, Family Law Division.

#### The Role of Minor's Counsel

California law regarding minor's counsel has evolved significantly in the past few years. Prior to 2010, the role of minor's counsel was to essentially act as an evaluator of sorts, making a report and recommendation to the Court regarding custody and visitation. This role began to change in 2007 with the case of Elkins v. Superior Court (2007) 41 Cal.4th 1337, 1368. In Elkins, the California Supreme Court held that family law litigants should have the same

due process protections as litigants in other types of civil cases. The court recommended that the Judicial Council of California establish a task force to "study and propose measures to assist trial courts in achieving efficiency and fairness in marital dissolution proceedings." In response to this recommendation, the Elkins Family Law Task Force was appointed.

The Elkins Family Law Task Force published its Final Report and Recommendations in April 2010, which states in pertinent part with regard to minor's counsel:

"The goal of [minor's] counsel's representation should be to provide the court factually correct information through the presentation of reliable, admissible evidence in a proper court proceeding. Because minor's counsel is acting in the role of an attorney, he or she should not make 'recommendations,' file a report, testify, or present anything other than proper pleadings."

The California Legislature responded to the Elkins mandate in 2011 by revising Family Code Section 3151 (a). The revised statute now provides that the role of minor's counsel is to gather "admissible evidence," not hearsay, and present the admissible evidence to the Court "in the manner appropriate for the counsel of a party."

Similarly, California Rules of Court, Rule 5.242 was amended in 2012 in response to the Elkins Family Task Force, to provide that "the role of the child's counsel is to gather evidence that bears on the best interest of the child and present that admissible evidence to the court in any manner appropriate for the counsel of a party."

# **Newest Minor's Counsel, continued...**

Family Code Section 3151 provides that "If the child so desires, the child's counsel shall present the child's wishes to the court." If the Court precludes the calling of the child as a witness, the child's testimony and other input "must be in writing and fully document the child's views on the matters on which the child wished to express an opinion" and "must be provided to the court and to the parties by an individual who will be available for testimony and cross-examination" (California Rules of Court, Rule 5.250 (d) (2) (A) and (B). ) The take-away from all of this, is that minor's counsel is no longer supposed to act in the capacity of a mini-evaluator, but rather, is constrained to only present admissible evidence in the same manner as any other attorney in the proceeding.

## Important Changes to Civil Code Section 1542

Senate Bill 1431, Chaptered in July 2018 and effective January 1, 2019, amended California Civil Code Section 1542, which precludes the waiver of unknown claims unless the protections of the section are expressly relinquished. The protections of



Civil Code Section 1542 cannot be waived unless the parties to the agreement actually acknowledge that they are waiving the rights and benefits of the statute, as quoted verbatim in the agreement.

Prior to amendment, Civil Code Section 1542 provided that a general release from an obligation does not apply to claims that the creditor does not know or suspect to exist in his or her favor, as specified, and that would have materially affected his or her settlement with the debtor.

Senate Bill 1431 clarified that the terms "creditor" and "debtor" include "releasing party" and "released party," respectively.

In summary, going forward, any document that contains a Civil Code Section 1542 waiver must include the new statutory language which now reads as follows:

"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."

#### JUDGE BACCIARINI TO SPEAK IN MERCED ON SMALL CLAIMS
