### **State Bar News Release**

State Bar of California Launches Groundbreaking All-Attorney Survey Analyzing the State of California Law Practice

Monday, June 24, 2019 - Today the State Bar opens online registration for an unprecedented survey of all active California attorneys, the California Attorney Practice Analysis (CAPA). Attorneys who sign up online between now and July 19 to participate in the August study will receive one hour of MCLE credit when they complete the survey.

"This expansive study is unprecedented, and we hope that California attorneys use this opportunity to give us their views about the present and future of the profession," said Alan Steinbrecher, who chairs the working group overseeing the project and is also Vice Chair of the State Bar Board of Trustees. "This analysis will help us definitively assess the relevance and content of the California Bar Exam. The practice of law, especially in a state as diverse and dynamic as California, is in a state of tremendous change. This fresh look at what entry-level attorneys need to know will help us ensure we are keeping up with that change."

The project will collect detailed, empirical data about how attorneys use their knowledge and skills to perform routine tasks in their legal practices. CAPA will set the foundation for revisiting the California Bar Exam content and format.

Participants will be assigned at random to one of three participant groups to complete:

- California-specific survey, which requires approximately 45 to 60 minutes to complete;
- A national survey fielded by the National Conference of Bar Examiners, of similar subject matter and length; or
- An Experience Sampling study, a method that involves brief responses to short, simple questions about current tasks, twice a day, for one business week. More information about ESM.

Numerous California attorneys have already contributed to the study, via the CAPA Working Group, as well as expert panels who helped formulate the knowledge domains on which the survey is based, on focus groups, in beta tests of the survey, and in a social media video campaign to promote the study, under the hashtag #LawPractice2020.

# **Family Law News**

At the June 2019 Merced Family Law Section Meeting, we discussed the recent case of *Look v. Penovatz* (2019) 34 Cal.App.5th 61, and its holding regarding a nonparent's request to be reimbursed from a parent for paying a child's living expenses.

Family Code Section 3950 states that a third party who provides the necessities of life for a child whose parent fails to provide them according to his or her circumstances, may recover their value from the parent.

In *Look*, the mother cohabitated with a man who helped pay the child's living expense and then filed a complaint against the biological father seeking reimbursement. The Appellate Court found that the man was not entitled to reimbursement, since the child's father regularly paid child support during the time that the child lived with the mother at the man's home.

Look is an interesting case, as we do not often see anyone seeking a claim for reimbursement under Family Code Section 3950, and it is a reminder that the statute is available for relief in appropriate circumstances.

#### **Notice of Ninth Circuit Opening**

There is a California vacancy on the U.S. Court of Appeals for the Ninth Circuit.

To assist Senator Dianne Feinstein in fulfilling her responsibility to ensure this vacancy is promptly filled, interviews are being scheduled for candidates who would serve with distinction as a Federal Appeals Court Judge.

#### **Merced Superior Court**

The Merced Superior Court is recruiting for a Staff Attorney I and a Staff Attorney III.

- Staff Attorney I: Under general direction, this professional level position performs legal research activities on behalf of the court by examining, analyzing, and interpreting available information and submitting recommendations for resolving issues before the court and will conduct ex parte hearings and related matters; conduct status review conferences.
- Staff Attorney III: Under general direction, this professional level position coordinates the work activities of the other staff attorneys and performs difficult and complex legal research activities on behalf of the court by examining, analyzing, and interpreting available information and submitting recommendations for resolving issues before the Court. The incumbent will conduct ex parte hearings and related matters, status review conferences, and serve, as directed, as a temporary judge. The incumbent serves at the pleasure of the Court Executive Officer.

# **Are You in Compliance?**

As of June 1, 2019, almost 5,000 California attorneys had not complied with the State Bar's order to be refingerprinted. Another 5,173 attorneys were in "compliance pending" status, meaning their fingerprints had been submitted but were awaiting final processing. An additional 1,000 lawyers' fingerprints were rejected and likely need to be re-submitted, according to the State Bar. Thus, about 6% of California's approximate 190,000 active attorneys have not yet achieved compliance with the re-fingerprinting requirement. Attorneys who remain in noncompliance as of December 1, 2019, will have their licenses suspended.

The re-fingerprinting process has resulted in thousands of criminal records for the State Bar to review, so that it may determine whether to pursue disciplinary action against implicated attorneys. As of May 1, 2019, the State Bar had discovered 2,659 misdemeanors and 40 felonies it did not previously know about. Another 140 FBI records were unclear as to whether they involved felonies or misdemeanors.
