Dr. Eric Sergienko to Speak at February 13, 2020 Meeting

The Mariposa County Bar Association is pleased to announce Dr. Eric Sergienko as the speaker for our next meeting, Thursday, February 13, 2020, at the Miner's Roadhouse 140, on the topic of Public Health Law. Dr. Sergienko is currently the Health Officer and Lead for the Director's Action



Working Group (DAWG), Mariposa County Health & Human Services Agency (HHSA).

As the Health Officer he provides expertise in all areas of Public Health. As the DAWG, he coordinates across HHSA programs and ensures data-driven decision making. Because of the 4.5 million visitors coming to Yosemite National Park within Mariposa County, Dr. Sergienko also ensures close working relations with state and federal health officials.

In addition to his work with the county, Dr. Sergienko provides technical expertise to the World Health Organization Emergency Operations Center Network. He was one of the authors of the Framework for Public Health Emergency Operations Centres.

Dr. Sergienko retired from the Navy in 2016. His last role was as the Department of Defense (DoD) Liaison to the Centers for Disease Control and Prevention (CDC). In this position he coordinated DoD and CDC activities including responses to Ebola, MERS, and Zika. He was also involved in the development of Incident Management training for CDC staff and DoD Public Health Emergency Management training.

He earned a Bachelor's degree with honors from Oregon State University and his medical degree from the Uniformed Services University of the Health Sciences. He has a Master's of Public Health from the University of Massachusetts – Amherst. He is board certified in Emergency Medicine.

New Rent Control Law Signed by Gov. Newsom in October 2019*

Governor Newsom recently signed a new law restricting residential rent increases and evictions. Assembly Bill 1482, the Tenant Protection Act of 2019, is being touted as the strongest tenant protection bill in the country. The law takes effect January 1, 2020. It is currently written to expire in 2030 and does not preempt any local rental ordinances.



Assembly Bill 1482: Tenant Protection Act of 2019

Under current law there is no state-wide cap on rent increases. Assembly Bill 1482 will prohibit an owner of residential real property from, over the course of any 12-month period, increasing the rent more than 5 percent, plus inflation.

Under current law, when the term of a lease expires, it is automatically renewed at the end of that term unless the landlord or the tenant gives written notice of that party's intention to terminate the lease. If the tenant has resided there for less than one year, the notice must be given at least 30 days before the end of the lease. If the tenant has lived there for more than a year, there must be 60 days notice. Under the current law, the landlord doesn't need to give a reason for eviction, so long as it isn't illegal, such as for discriminatory or retaliatory purposes. The landlord can simply give a written notice to move and specify the date on which the tenancy would end.

Assembly Bill 1482, with certain exceptions, will prohibit a landlord from ending a lease without "just cause," when the tenant has lived there for at least one year. Examples of "just cause" could include a tenant's default in the rent, sublet of the property without permission, or an illegal activity on the property. Before a landlord can end a lease for these reasons, the tenant must be given an opportunity to fix the violation. The landlord can also terminate the lease for several allowable reasons, such as wanting to move a family member into the house or remove the property from the rental market. Depending on the reason, the law may require that the landlord provide relocation assistance to the tenant, such as waiving the last month's rent.

Assembly Bill 1482 Exempts Certain Rental Properties

Assembly Bill 1482 does not apply to housing accommodations in which the tenant shares bathroom or kitchen facilities with the owner who maintains their principal residence at the residential real property. Also exempt are duplexes where the owner occupies one of the duplex units as their principal place of residence. It also does not apply to single family owner occupied residences in which the owner-occupant rents no more than two units or bedrooms, including but not limited to an accessory dwelling unit or junior accessory dwelling unit. New housing that was issued a certificate of occupancy within the previous 15 years is exempt. In addition, single family residential real property that is separate from the title to any other dwelling unit is exempt, provided that the owner is not a real estate investment trust, a corporation, or a limited liability company in which at least one member is a corporation.

If the rental is exempted, the tenant must be given a written notice that the residential property is exempt from the provisions of Assembly Bill 1482, using the language provided in the statute.
