Family Law News

The featured case this month is *Siry Investment v. Farkhondehpour*, issued March 3, 2020. Although *Siry* is not a family law case, it deals with discovery sanctions which are applicable in family law as well as all other civil cases. Almost every family law attorney has been on the receiving end of opposing counsel refusing to provide good faith responses to discovery. In family law, this is particularly egregious in light of the parties' fiduciary duty to disclose all information even without a discovery request, per the California Family Code.

In Siry, after the defendants committed multiple discovery abuses, the Trial Court issued a terminating sanction and allowed the matter to proceed by default prove-up, resulting in a \$7 million default Judgment. The defendants appealed, contending that because the discovery they failed to respond to did not address all the issues in the case, a terminating sanction was not appropriate. In affirmation, the Appellate Court states: "We conclude that a trial court is not foreclosed from issuing terminating sanctions just because the underlying discovery encompasses only a subset of the issues in the case." The Court found that although terminating sanctions are the most drastic penalty and are typically a last resort to be used sparingly, the defendants obstinately refused to provide discovery responses, had a profuse history of discovery abuse, and engaged in willful and calculated conduct intended to frustrate and evade the discovery process. As best stated by the Court: "Defendants have a fulsome history of discovery abuse: They ignored Siry's two rounds of post-remand discovery and then flouted multiple court orders to provide documents and responses without objection, preferring instead to make multiple motions for clarification and reconsideration, to bury Siry and the court with "document dump[s]," and then to try to avoid the consequences of their discovery misconduct by making feckless, last-minute offers to rummage through their files for responsive documents. Defendants' conduct was both willful and, worse yet, calculated".
