State Bar News

The State Bar's "First Annual Report Card on the Diversity of California's Legal Profession," was published July 20, 2020, and provides baseline data on the diversity and workplace satisfaction of California's attorney population across multiple demographic groups and employment sectors.

The report brings into stark reality that despite significant growth in the proportion of attorneys who are women and people of color over the past 30 years, California's attorney population remains far from reflective of the state's diversity. The report may be viewed at the State Bar website.

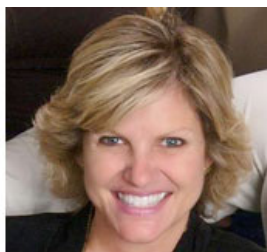
