Justice Martin J. Jenkins Confirmed to California Supreme Court

Justice Martin J. Jenkins has been confirmed to the California Supreme Court. Praised for his "brilliant intellect, first-class temperament, and boundless humanity," Justice Jenkins makes history as the first openly gay California Supreme Court justice and only the third African American man to serve on the state's highest court. The Judicial Branch of California has issued the following News Release:

November 10, 2020 -- Chief Justice Tani G. Cantil-Sakauye, chair of the Commission on Judicial Appointments, announced that the commission today confirmed Justice Martin J. Jenkins as Associate Justice of the Supreme Court of California.

The appointment was approved by a unanimous vote in the Supreme Court Courtroom in San Francisco.

A report by the Commission on Judicial Nominees Evaluation found Justice Jenkins "exceptionally well qualified"—the highest possible rating—for service on the California Supreme Court. "He is praised for his brilliant intellect, first-class temperament, and boundless humanity," the report said.

2020 SECURE Act Impacts Estate and Retirement Planning*

On December 20, 2019 President Trump signed into law the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019. This law, which went into effect on January 1, 2020, made changes to how Individual Retirement Accounts (IRAs) are used for estate and retirement planning. An IRA is an



account set up at a financial institution that allows an individual to save for retirement with certain tax-saving benefits, depending on the type of IRA.

Prior to the SECURE Act, children who inherited a parent's IRA could "stretch" out their distribution over their own life or life expectancy. This allowed children beneficiaries to take the minimum distribution each year, thereby preventing them from moving into a higher tax bracket. It also enabled the children beneficiaries to spread out the payment of taxes on their inheritance from an IRA. These so-called "stretch IRAs" were mostly eliminated by the SECURE Act. Non-spouse beneficiaries of inherited IRAs must now withdraw and pay taxes on all distributions from inherited accounts within 10 years. This rule also applies to inherited funds in a 401(k) account or other defined contribution. There are exceptions to this rule for surviving spouses, disabled individuals, minor children and individuals not more than 10 years younger than the original account owner. If you had already inherited a stretch IRA prior to the SECURE Act, you aren't affected as the new law only applies to beneficiaries of someone who dies after the end of 2019.

The SECURE Act made some other key changes to retirement planning. The SECURE Act pushed back the age at which retirement plan participants need to take required minimum distributions from 70 $\frac{1}{2}$ to 72 (for those who are not 70 $\frac{1}{2}$ by the end of 2019). Beginning in the 2020 tax year, the SECURE Act also now allows traditional IRA owners to continue to make contributions to their plans after the age of 70 $\frac{1}{2}$, so long as they are still earning wages or self-employed income.

Other highlights of the SECURE Act include provisions allowing penalty-free withdrawals from tax deferred accounts for certain purposes. Normally, if such withdrawals occur before the age of 59 ½ it is subject to a

10% early withdrawal penalty. The SECURE Act allows penalty-free withdrawals for qualified birth or adoption expenses, up to \$5,000 per individual. A couple each having their own individual account could then withdraw penalty-free a total of \$10,000 for qualified birth or adoption expenses. The SECURE Act also allows penalty-free withdrawals of up \$10,000 from tax-advantaged 529 accounts for qualified student loan repayments. Under the new law, a 529 plan may also be used to pay for certain apprenticeship programs without the early withdrawal penalty.

Jenkins Confirmed, cont.

Justice Martin Jenkins fills the vacancy created by the retirement of Justice Ming Chin on Aug. 31. Justice Jenkins is the first openly gay California Supreme Court justice and only the third African American man ever to serve on the state's highest court.

Justice Jenkins has held several prominent state and federal judicial positions throughout his career, his most recent role as the Governor's judicial appointments secretary. In that role, he spearheaded transparency efforts by making public the Regional Judicial Selection Advisory Committees, so that for the first time in California history, the individuals who provide feedback on judicial candidates for nomination and appointment will be known to the public.

Justice Jenkins has worked closely with these committees and the Governor to build a judiciary that reflects the people they serve, appointing a diverse group of 45 jurists that will help shape the California judiciary for years to come.

Prior to his role in the Newsom administration, Justice Jenkins served as an associate justice on the First District Court of Appeal from 2008 to 2019. He was appointed by President Bill Clinton to the U.S. District Court for the Northern District of California in 1997 and served on that bench until 2008.

Justice Jenkins served as a judge on the Alameda County Superior Court (1992-1997) and on the Oakland Municipal Court (1989-1992). From 1986 to 1989, he was a trial attorney with the Pacific Bell Legal Department of San Francisco and from 1983 to 1986, he worked in the U.S. Department of Justice as a trial attorney litigating civil rights cases. From 1980 to 1983, he worked as a prosecutor for the Alameda County District Attorney's Office.

Justice Jenkins earned a Juris Doctor degree from the University of San Francisco School of Law.

Family Law News

Is Calling Opposing Counsel a "Liar" Contemptuous?

The featured case this month is Moore v. Superior Court of Orange County (11/16/20) In Moore, during a mandatory settlement conference before a temporary judge, petitioner's attorney was rude and unprofessional. Among other things, petitioner's attorney (1)persistently yelled at and interrupted other participants; (2) accused opposing counsel of lying while providing no evidence to support his accusation; (3) refused to engage in settlement discussions; and (4) effectively prevented the settlement officer from invoking the aid of the supervising judge. After a hearing, respondent court convicted petitioner's attorney of four counts of civil contempt, and the attorney appealed.

The appellate Court held that the conduct of petitioner's attorney was in fact contemptuous, but that the conduct should have been consolidated into one count of contempt rather than four. In finding the behavior to be contemptuous, the Court states:

"The contempt conviction in count two was based on [petitioner's attorney] brazenly accusing opposing counsel [Parnall] of "lying" without identifying any lie. A lawyer's core function includes demonstrating through evidence and argument that an opponent's statements are inaccurate, incomplete, or misleading. That function is never properly discharged through name calling or by hurling insults. Interrupting an opponent's presentation to loudly proclaim that opponent is "lying" or is a "liar" undermines the legal process. This sort of tactic is inappropriate in a courtroom and is objectively disrespectful of our system of justice. (See In re Buckley (1973) 10 Cal.3d 237, 250-255 [statement that judge "obviously doesn't want to apply the law" was objectively contemptuous].) In a word, it is contemptuous.....[Petitioner's attorney] demonstrated a total lack of respect for the court, the settlement officer, opposing counsel, and the opposing party. This was contemptuous."

The Appellate Court concluded by directing the Clerk of the Court to provide a copy of the Court's opinion to the State Bar.
