President's Column



You Make the Difference: Be Engaged, Be Pro Bono

The recent pandemic and its economic consequences have disproportionately affected low-income individuals and communities, people of color, and others already struggling for social justice. Today, there are many more people eligible for legal aid, when



only months ago no one could have predicted they would find themselves in this position. Legal aid resources are stretched thin, and inadequate to meet the demand for assistance with legal issues such as preventing evictions and homelessness, meaningful access to health services and public benefits, and protections for victims of domestic violence.

The role of pro bono attorneys in mitigating this crisis has been specifically addressed in open letters from the Chief United States District Judge of the United States District Court, Eastern District of California, and the President of the American Bar Association, calling on bar associations and individual attorneys to mobilize and engage in pro bono service.

Your individual contribution makes all the difference. Whether a family avoids homelessness by having legal representation in their unlawful detainer case, or a victim of domestic violence secures a restraining order against their abuser, often hinges on whether a volunteer attorney is willing and able to serve. Legal aid simply cannot accomplish its mission without you.

CCLS has a wide range of volunteer opportunities, with different time commitments, levels of services provided, and areas of substantive law. Training and supervision is provided, so you may volunteer outside of your regular practice areas. Volunteers are also covered by CCLS' professional liability insurance policy.

As we look back over 2020, we are reminded of Law Day 2020, which celebrated the 100th Anniversary of Women's Right to Vote. Reprinted here with the permission of the *Mariposa Gazette*, is the article authored by Anita Starchman Bryant in recognition of Law Day:



Law Day Celebrates 100th Anniversary of Women's Right to Vote

In 1961, May 1st was proclaimed to be National Law Day. Law Day is a day for celebrating our legal system. This year's Law Day theme is "Your Vote, Your Voice, Our Democracy: The 19th Amendment at 100." Each year the American Bar Association designates a new Law Day theme. The ABA chooses an annual theme to spotlight a particular aspect of law or the legal process and its impact on our daily lives. As stated on the ABA's website "Law Day provides an opportunity to understand how law and the legal process protect our liberty, strive to achieve justice and contribute to the freedoms that all Americans share."



The ABA's 2020 theme not only celebrates the rule of law, but also an important anniversary in our nation's history. This year is the 100th anniversary of the passage of the 19th Amendment, guaranteeing and protecting women's constitutional right to vote. As ratified and certified in August 1920, the 19th Amendment states "The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex. Congress shall have power to enforce this article by appropriate legislation." The passage of the 19th Amendment marked the largest expansion of democracy in the history of our country.

ABA President Judy Perry Martinez states that "[t]his historic centennial offers an unparalleled opportunity to commemorate a milestone of democracy and to explore its relevance to the issues of equal rights today."

The 100th anniversary of the U.S. Constitution granting women the right to vote celebrates a historic time in American democracy. The 19th Amendment is sometimes called the "the Anthony Amendment" because of the prominent role of suffragist Susan B. Anthony.

Long before the passage of the 19th Amendment, in 1870, Wyoming was the first territory to grant women the right to vote. That same year Wyoming (appropriately nicknamed "the equality state") made history with several other "firsts" in the nation such as having the first jury to include women and the first woman to serve as a judge in the United States. California granted the state's women the right to vote in a special election on October 10, 1911. According to the ABA, more than 80 million women are now registered to vote.

In observance of Law Day, local bar associations are encouraged to reach out to schools and discuss the American legal system with students. This year the California Lawyers Association has rolled out an online toolkit to educate students on the importance of voting rights. This toolkit, available on the California Lawyers Association website, can be used by educators online or in local classrooms after schools reopen. Legal clinics have been a staple at CCLS since the beginning, and now is no exception. Since May of this year, we have retooled to offer legal information clinics virtually via Zoom, completing about 20 of them. The clinics have had tens of thousands of views on social media. We are reaching more people than we ever were before. We continue to schedule and host clinics, on a wider variety of topics, and in more languages. Most of the clinics rely on volunteer attorneys or other legal professionals.

CCLS has been hard at work rolling out three virtual clinics to provide counsel and advice, and brief services, in the areas of eviction defense, criminal record expungement, and domestic violence.

The Unlawful Detainer Clinic utilizes the Zoom meetings platform to enable volunteer attorneys and CCLS staff attorneys to provide legal advice and prepare and file answers for tenants facing eviction. Tenant protections are sunsetting, and the underlying economics have only gotten worse. We expect significant demand for this clinic in the coming months.

The Criminal Record Expungement Clinic is a partnership between CCLS, Fresno County Public Defender's Clean Slate Program, Root and Rebound, and Law Students for Community Advancement. In October we held an attorney MCLE recruiting event and a public information session, both virtually via Zoom webinars. The clinic pairs volunteer attorneys with law students to assist clients with applications and petitions for criminal record expungement. Volunteer attorneys work their cases on their own time, with case support from the law students, and substantive expertise from the Clean Slate Program and Root and Rebound. A criminal record often separates an individual from obtaining housing, employment, and other basic necessities. This clinic will have a huge impact on our community.

Project First Step is CCLS' flagship clinic that provides limited scope representation to victims of domestic violence seeking restraining orders against their abusers. Marjaree Mason Center and Fresno County Women Lawyers have been long time partners, and new for this year is a partnership with the Fresno County Superior Court. Our upcoming MCLE recruiting event is scheduled for Saturday, January 23, 2021, from 8:30am to 12:30pm.

One Third of Remote Bar Exam Test-Takers Receive Violation Notices

The National Conference of Bar Examiners provided testing materials with remote proctoring for jurisdictions, including California, that offered the October 2020 online bar exam. The jurisdictions are responsible for reviewing potential administration issues.

During the December 4, 2020 meeting of the California Committee of Bar Examiners, it was reported that 8,920 applicants took the exam online. Of that group, 3,190 (nearly 36%) of the test-takers had their videos flagged for review.

"During the video review process, a Chapter 6 Notice is issued to any applicant who is believed to have violated examination rules and policies," the Bar said. "A Chapter 6 Notice is not a finding of a violation or sanction. Rather, it provides an applicant with the opportunity to respond in writing before any finding is made." The Chapter 6 Notices, some of which were reportedly unsigned and undated, give test-takers 10 days to provide a statement in response. Some of the notices pertained to whether examinees' eyes were always visible throughout the two-day test.

The Bar's office of admissions will consider information and evidence in applicants' responses to violation notices, to decide whether to affirm the violation notice. If the violation is affirmed, the office determines whether a sanction should be imposed, which could include warnings, a score of zero for the flagged sessions or the entire exam, and negative marks on character and fitness evaluations.

If an applicant disagrees with the office's determination, the applicant may request an administrative hearing. An unfavorable outcome can be appealed with the Committee of Bar Examiners and, ultimately, the California Supreme Court. The applicant's October bar exam scores will be held in abeyance while hearings and appeals are resolved, and the applicant is not permitted to take the February 2021 exam when determinations of previous scores are pending. Several law school deans are urging the State Bar to allow applicants to sit for the February 2021 bar while they are challenging the Chapter 6 Notices.
