# State Bar of California Releases Results of October 2020 Bar Exam

The State Bar has released the results of the October 2020 California Bar Exam and announced that 5,292 people (60.7 percent of applicants) passed the General Bar Exam. If those who passed satisfy all other requirements for admission, they will be eligible to be licensed by the State Bar to practice law in California. The October 2020 General Bar Exam pass rate is the highest in more than a decade, since July 2008.

"We heartily congratulate the 5,292 applicants who passed the General Bar Exam and the 323 candidates who passed the Attorneys' Exam in this tremendously challenging year. We are pleased that the first-ever remote bar exam will result in such a large influx of new attorneys at a time when more people than ever need legal help. We hope to welcome all those who passed to California's legal profession very soon," said Donna Hershkowitz, Interim Executive Director of the State Bar.

The October bar exam was unprecedented in several ways:

- It was administered to a near-record number of examinees, 9,301, the largest cohort since 2013.
- It was the first-ever to be administered online remotely. Of the total cohort, 8,920 took the exam online.
- It was the first exam graded under the new cut score of 1390, reduced from 1440 by the California Supreme Court on July 16, 2020.

## Civil Rights Committee Objects to Facial Recognition Technology with Remote Bar Exam

The October 2020 Bar Exam was the first time in history that the California Bar conducted the Bar Exam online. To ensure the continued identification of applicants during the Exam, the Bar Examiners contracted with ExamSoft, who used Facial Recognition Technology (FRT).

The Lawyers' Committee for Civil Rights Under Law is now threatening to sue the California State Bar unless it agrees to stop using FRT with online bar exams.

The Committee is concerned that the use of FRT discriminates against women, people of color, those with disabilities, or those wearing religious garments. Several test takers of color reported being shut out of the October 2020 online exam because the FRT did not recognize them.

"It is by now well-established by experts in that field that FRT is disproportionately inaccurate in identifying women and people of color," the Lawyers' Committee for Civil Rights Under Law said in a February 10, 2021 letter to the California State Bar. "As a result, its use will have an unlawful disparate impact on examinees of color and women examinees."

The Committee states it "will be forced to take legal action" if the Bar does not take "immediate steps" to stop using FRT in future exams.

• It was the first exam graded under a streamlined two-phase grading system, approved by the Committee of Bar Examiners in August 2020 to increase efficiency and shorten the grading timeline.

# **October 2020 General Bar Exam preliminary statistics**

- Completed the exam: 8,723 applicants
- First-time applicants: 4,990 (57.2 percent of total)
- Pass rate for first-time applicants: 74.0 percent overall
- Repeat applicants: 3,733 (42.8 percent of total)
- Pass rate for repeat applicants: 43.0 percent overall

The Family Law Section of the San Luis Obispo County Bar Association has announced the 5th Annual SLO Minor's Counsel Training - Virtual Seminar on March 26th, 27th and 28th. The State Bar has asked the MCBA to provide the following information to our members:

The State Bar seeks members for the statewide Commission on Judicial Nominees Evaluation (JNE). If you are an active California attorney in good standing, a former judicial officer, or member of the general public. the State Bar invites you to apply. The 38 member JNE commission assists the Governor in the judicial candidate vetting process by providing independent, comprehensive, and fair candidate evaluations. The ideal candidate has the skills and experience necessary to conduct an investigation, assess qualifications for service on the bench and provide timely and well-written reports.

Time Commitment: There are six two-day meetings per year (currently held via Zoom), in addition to a mandatory two-day orientation meeting to be held January 28-29, 2022, and a minimum of 20 to 40 hours investigation/evaluation of work per month.
