JUDGE FAGALDE, KEYNOTE SPEAKER AT ANNUAL LAW DAY LUNCHEON

Judge Michael A. Fagalde will be the Keynote Speaker at the Mariposa County Bar Association annual Law Day Luncheon on May 12, 2022.

Judge Fagalde is the presiding Judge for the Mariposa County Superior Court. He was elected to the bench in 2014.

Judge Fagalde received his B.S. degree from San Jose State University in 1975. He graduated with his Master's degree from Walden University, and earned his JD from Santa Clara University School of Law in 1983.

Prior to his election to the bench, Judge Fagalde was a partner at the law firm Fagalde, Albertoni, and Flores LLP, and was named Mariposa's Best Attorney by the Mariposa Gazette.

During his tenure on the bench, Judge Fagalde was instrumental in helping to establish the Behavior Health Court in Mariposa County in 2017. Behavioral Health Court is a problem-solving Court which aims to aid a specified problem such as drug use, mental health illness, and domestic violence with specialized treatment that incentivizes adherence to treatment plans and applies legal sanctions to nonadherence. The Behavioral Health Court consists of the Superior Court Judge, Deputy District Attorney, Probation, Defense, and two Behavioral Clinicians.

Judge Fagalde's memberships have included the Mariposa Rotary Club, the Mariposa County Bar Association, the John C. Fremont Hospital Foundation, and the Mariposa School foundation.

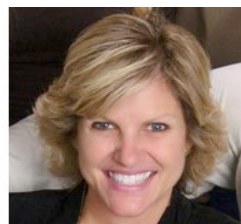
