We will kick off the New Year with our meeting on January 12, 2023, with Mariposa District Attorney Walter Wall providing a presentation on legislative updates.

District Attorney Wall is a certified Criminal Legal Specialist. Criminal legal specialization is a distinction achieved by less than 1% of District Attorneys in California. Criminal legal specialization requires a lengthy resume of trials, legal issues, and experience in criminal law that are realized after a specialized certification examination and presented to the criminal legal specialization division of the California Bar Association, which then confers the specialist on the duly qualified candidate. Of the elected District Attorneys in California, Mr. Wall is the only one who is a Criminal Legal Specialist.
