WELCOME TO OUR NEW VICE PRESIDENT, RENA HARRISON

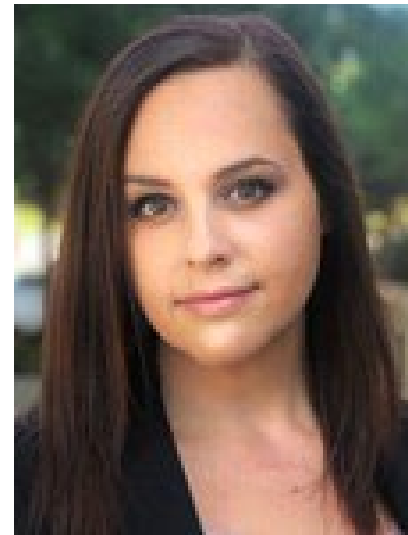
