Mariposa County Behavioral Health and Recovery Services is a division of Mariposa County Health & Human Services Agency. The office is located at 5362 Lemee Lane, Mariposa, CA 95338.

There is a wide range of mental health services and substance use disorder services provided for children, youth and adults. Services available include:

- Individual, Group, and Family counseling
- Psychiatric services (including medication management)
- Case Management
- Substance Use Disorder (SUD)
- 24/7 Crisis Response
- Behavioral Health Court
- Wellness Center
